In consideration for allowing this child to participate in this Activity, we hereby forever release, waive, hold harmless, acquit, and forever discharge the City of Gardendale from any and all claims, causes of action, or liability that may arise from or be related to this activity. Notwithstanding anything else to the contrary herein, the liability of the City of Gardendale shall be limited to a maximum of the return by the City of Gardendale of any fees paid on the child's behalf (if any) for the Activity, and in no event shall the City of Gardendale be liable for any other damages (including, but not limited to, damages from personal injury, mental anguish, emotional distress, or indirect, special, consequential, punitive, exemplary, or incidental damages) regardless of (a) the City of Gardendale's negligence or the negligence of others, or (b) whether the City of Gardendale has been informed of the possibility of such damages. Any claim or dispute arising from or related to the use of these facilities shall be settled by mediation and, if necessary, legally binding arbitration in accordance with the current rules of the American Arbitration Association. Judgment upon an arbitration decision may be entered in any Court otherwise having jurisdiction. We understand that these methods shall be the sole remedy for any controversy or claim arising out of the use of these facilities and expressly waive our right to file a lawsuit and may right to a jury trial in any civil court against the City of Gardendale for any dispute, except to enforce an arbitration decision.
